We will be able to accept a maximum of 11 entries. Each division tournament will run approximately 2.5 hours. Players will have the opportunity to play against 12-14 other registrants, and partner with 6-7 of the other players during their assigned rotations, who you play with and against will be determined by the order registrants sign in on the day of game play. The first, second, and third place winners will be given awards, and will have their names posted in the lobby of the Activity Center. Players waiting in by, and/or BBBPRD2 staff will act as referees. Each game will run to 9 points, or until the per game time of 15 min expires. The pair with the highest score will win the round if 9 points have not been reached when the game play time expires.

RELEASE, PERMISSION, AND INDEMNITY AGREEMENT

Waiver. In consideration of being permitted in any way in the Blaine-Birch Bay Park and Recreation District 2 Pickleball Tournament (“the Tournament”), I, for myself, my heirs, or assigns, **do hereby release, waive, discharge and covenant not to sue** Blaine-Birch Bay Park and Recreation District 2, their officers, employees and agents from liability **from any and all claims** resulting in personal injuries, accidents, or illnesses (including death) and property loss arising from my participation in the Tournament.

Assumption of Risk. Participation in the Tournament carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary, but include 1) minor injuries such as bruises, strains and dehydration, 2) major injuries such as eye injuries, joint, bone, or back injuries, heat stroke, heart attacks, and concussions, and 3) catastrophic injuries such as paralysis and death. **I have read the previous paragraphs and I know, understand and appreciate these risks that are inherent in playing pickleball. I assert that my participation is voluntary and that I knowingly assume all such risks.**

Indemnification and Hold Harmless. I also agree to indemnify and hold harmless the Blaine-Birch Bay Park and Recreation District 2 from any and all claims, actions, suits, costs, expenses, damages, and liabilities, including attorney’s fees brought as a result of my involvement in the Tournament.

Use Permission. I also give the Blaine-Birch Bay Park and Recreation District 2 and all it’s agents and designees permission to use or distribute without limitation or obligation, my image, name, voice, and words for any purpose connected with the Tournament, including promotional, marketing, training, informational, and archival use.
